# This means that you should be able to

- Change colours, contrast levels and fonts
- Zoom in up to 300% without the text spilling off the screen
- Navigate most of the website using just a keyboard
- Navigate most of the website using speech recognition software
- Listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver)

We've also made the website text as simple as possible to understand.

## **Google Chrome**

Go to the Customize and control Google Chrome icon at the extreme right of the top tool bar. Right mouse click on this and go to Zoom, increase the size as you wish.

#### Internet Explorer

Go to the 'View' menu and select one of the options under 'Zoom'.

#### Mozilla Firefox

Go to the 'View' menu and select one of the options under 'Zoom'.

#### Opera

Go to the 'File' menu, select 'Preferences' then 'Fonts' and then change 'Minimum font size (pixels)'.

#### Safari

Go to the 'View' menu and select 'Make Text Bigger' or press the Apple (cmd) Key and the plus key (+).

## How accessible this website is

We know some parts of this website are not fully accessible

- The text will not reflow in a single column when you change the size of the browser • window
- You cannot modify the line height or spacing of text
- Most older PDF documents are not fully accessible to screen reader software
- Live video streams do not have captions
- Some of our online forms are difficult to navigate using just a keyboard
- You cannot skip to the main content when using a screen reader
- There's a limit to how far you can magnify the map on our 'contact us' page ٠

# Enforcement procedure

# **Compliance status**

The website has been tested against the Web Content Accessibility Guidelines (WCAG) [2.1 or 2.2] AA standard.

The MS-UK is not compliant of the WCAG 2.1 AA standard. This is be due to one or both of the following

- non-compliances this means the content in question is in scope of the regulations, but there's an accessibility problem with it
- an exemption this means the inaccessible content is out of scope of the regulations, or it'd be a disproportionate burden for you to make it accessible

This website is partially compliant with the [Web Content Accessibility Guidelines version 2.1 AA standard or Web Content Accessibility Guidelines version 2.2 AA standard], due to the non-compliances and exemptions listed below.

## Non-accessible content

The content listed below is non-accessible for the following reasons.

- Background and foreground colours do not have a sufficient contrast ratio
- Heading elements are not in a sequentially-descending order
- Links do not have a discernible name
- [user-scalable="no"] is used in the <meta name="viewport">element or the [maximum-scale] attribute is less than 5
- Amend header tags on pages to go in line, such as H1 to H4 etc.
- Amend media library images to have descriptive meta descriptions

MS-UK will work toward rectifying these issues by October 2024 when the next audit is due.

# PDFs and other documents

We do not plan to add captions to live video streams because live video is exempt from meeting the accessibility regulations.
